Annual Meeting Speaker Offers Insurance Options to Address Long Term Care Costs

A life insurance policy with a long term care rider will save you money over buying a standalone long term care (LTC) policy, according to the financial expert who addressed attendees at the VCCCD Retirees Association annual meeting in March.

Mr. Richard G. Hanson, speaking on behalf of the Foundation for Financial Education, made this the key point of his keynote address to more than 60 retirees and guests who gathered at the VCCCD headquarters in Camarillo on March 20, the first day of spring. His presentation was titled "Mitigating the Costs of Long Term Care."

Consumers can save money because the long term care rider of a whole life policy can provide up to three times or more than its face value in LTC benefits if the policyholder should need long term care. If the LTC benefit is not used, the face value of the policy will be paid to the beneficiaries upon the death of the insured.

In contrast, a standalone LTC policy has no death benefit. Even worse, if the policy lapses

or the LTC benefit is not used, the insurance company keeps all the premiums and pays nothing.

In Mr. Hanson's experience, the best companies currently offering life insurance policies with LTC riders are Allianz, Minnesota Life, and Securian Financial.

Chancellor's Presentation

Rene Rodriguez, president of the VCCCD Retirees Association, convened the annual meeting by thanking Chancellor Greg Gillespie for allowing the use of the Board Room for this event.

Dr. Gillespie warmly welcomed retirees and thanked them for their many years of service to the District. He also updated the audience on the following developments:

(1) VCCCD's funding is now driven by the Student Centered Funding Formula, which includes factors for FTES, student characteristics (e.g. low income, underrepresented), and student success (e.g. degrees and certificates).

(2) Efforts are underway to establish a districtwide foundation to generate resources for initiatives that will benefit students at all three colleges.

Vice Chancellor's Presentation

In addition to Dr. Gillespie, Mr. Michael Shanahan, Vice Chancellor of Human Resources, described the District's efforts to place its employee benefits package with a statewide JPA (joint powers agency) such as CalPERS.

Of all the JPAs that could underwrite the benefits coverage, only CalPERS is willing to accept VCCCD's employees and retirees without requiring that all eligible retirees first be enrolled in Medicare Parts A and B.

However, CalPERS will accept VCCCD only if all its eligible retirees sign up for Medicare Parts A and B within one year of the transition to CalPERS. The other JPAs require all retirees to be in Medicare before they will consider VCCCD as a client.

Burnham Benefits, the District's benefits consultant and broker, continues to work with the districtwide Benefits Committee to study this issue and, hopefully, to resolve the matter in time for the Spring 2020 open enrollment period.

Burnham will also continue to seek Medicare supplements for retirees. Anthem Blue Cross is not an option because it does not offer a group Medicare supplement.

CalPERS has many PPO and HMO options its active and retired enrollees may choose from. Depending on the individual choices, the District could achieve premium savings of \$10 to \$20 million per year.

Other Business

Attendees unanimously approved the minutes of the March 21, 2018 annual meeting, prepared by Marie Soo Hoo. They also reviewed the annual treasurer's report, prepared by Patricia Gage.

Due to time constraints, President Rene Rodriguez dispensed with reports from the Benefits Committee (Gary Johnson), Educational Issues Committee (Larry Manson), Membership Committee (Joy Kobayashi), Social Committee (Marie Soo Hoo), Newsletter (Harry Culotta), Webmaster (Rene Rodri-

guez), and Blogmaster (Carmen Guerrero).

The next order of business was the election of officers to serve the Association from July 1, 2019 through June 30, 2021. Larry Manson, representing the Nominating Committee, announced there were no candidates for president and one candidate for vice president.

Attendees voted unanimously to take the following actions:

--To re-elect Rene Rodriguez to serve as president (nominated by John Woolley), and

--To elect John Woolley to serve as vice president.

Rene Rodriguez then introduced Harry Culotta, immediate past president. Harry presented a proposal to raise the VCCCD Retirees Association dues to \$20 per year, or \$200 lifetime, to become effective on July 1, 2020.

He explained that the current dues of \$10 per year or \$100 lifetime have been in effect since 2000, while the costs of running the Association have increased greatly. The proposal was approved unanimously by those present.

Finally, Rene Rodriguez presented a proposal for the Association to explore the possibility of establishing a permanently endowed student scholarship in the name of Donald B. Medley, the late founder of the Association.

The proposal envisions a single scholarship of \$500 per year, each year, which could rise as the amount of the endowment increases. Rene noted that if half of Association members made a one-time contribution of \$25, the endowment could be funded.

Attendees voted unanimously to authorize the Association to explore the possibility of the Don Medley Scholarship and to work out the details.

Earlier in the meeting, Rene had circulated an insurance benefits survey, prepared by Gary Johnson. Rene asked everyone to return the survey, and stated it would also be sent to all retirees with e-mail addresses

As the meeting concluded, Rene thanked all three guest speakers for sharing their knowledge, and he also thanked everyone for attending the annual meeting.
